



I could make weekend jaunts to Baltimore, Washington, D.C., or New York, NY. I went to Washington, D.C. most of the time, where I made visits to the Washington Monument, Smithsonian, Lincoln Monument, and many other places of interest. One place that was the first stop was the USO. Tickets for events around Washington were always available and I made pretty good use of them.

The base had an excellent Enlisted Man's Club. Spent many a night there having a few beers and "BSing" with my classmates. Never had a dull night at that club.

I remember one Saturday (had weekend duty) where a few of us were discussing stuff late into the evening in one of those rooms that was in the center of the building. The room contained a couple of round tables and many chairs that were used most of the time for playing cards. Some of us were leaning back in our chairs and then one person leaned back too far and tipped over. That was one loud noise as the chair hit the deck and I thought the noise would wake up everyone in the building! The noise did attract one new person and that was the First Class Petty Officer who had the barracks duty. He accused us of having a fight and would not believe otherwise. He also indicated that he was going to "Keep an eye on us and that we had better not have a repeat." Was it ever difficult to keep from leaning back in our

chairs! I often wondered how you can convince someone of the truth when "they know better."

## That Good Navy Chow Cry Baby Cookies



Yield: Approximately 4 dozen cookies

1/2 cup shortening
1/2 cup sugar
1/2 cup molasses
1 egg, well beaten
3 cups sifted cake flour
1-1/2 teaspoon baking powder

3/4 teaspoon soda
1 cup shredded coconut
1 cup chopped nuts (optional)
3/4 cup raisins
1/2 cup whole liquid milk

- 2: Sift together flour, baking powder, and soda. Combine with coconut, nuts and raisins.
- 3: Add dry ingredients alternately with milk to the creamed mixture.
- 4: Drop approximately 1 tablespoon of dough per cookie, 2 inches apart, on greased baking sheet.
- 5: Bake at 375' F for 10 minutes.

Dear Shipmate,

This letter is being written to you to ask for your help in saving the USS Ranger CV-61 from being sold for scrap. As you know this is what happened to our Coral Sea . It was announced at our last reunion in Williamsburg VA in October that the last vestige of Coral Sea was hauled out of the Baltimore MD harbor on August 9,2000.

By way of background I served aboard Coral Sea as XO/CO of VF-154 and as CAG 15 from '62-'65. My naval career progressed and I became the Commanding Officer of the USS Ranger CV-61 from 9/71 to 5/73. The Ranger was decommissioned in 1993 and is berthed in Bremerton WA Naval Shipyard as part of our "mobile assets" (mothball fleet). Under current planning when the USS Constellation CV-64 is decommissioned in 2003, Ranger will be transferred to the disposal list. At that time she will be eligible to be donated as a museum/educational facility or sold to the highest bidder.

There is an organization that has been working hard for more than two years to be in a position to have a plan and funding in place to be awarded the Ranger as a museum/educational facility by the Navy Department. This organization is Seaport Northwest Inc in Everett WA., just north of Seattle on Puget Sound.. I have made a commitment to SAVE RANGER. I have accepted a seat on the Board of Directors (BOD) of Seaport Northwest.

Also, I am involved with the USS Ranger Reunion Assn. I served on the BOD until term limits prevented my continuation there. I was appointed Special Advisor to the president and point of contact between the Assn and Seaport Northwest

Here is my request to you. I am asking for a 20 dollar donation to save Ranger from the scrap heap. While Seaport Northwest has a non-profit status in the state of Washington, the paperwork is in progress to get an IRS determination as a 501c3 status so that donations are tax deductible. In the meantime, in order for your donation to be tax deductible on your federal tax return please make your check payable to the USS Ranger Reunion Assn (which does have an IRS 501c3 non-profit status). The Ranger Assn will pass all of your money to Seaport Northwest

#### SUBJECT: MESOTHELIOMA

Do you know what Mesothelioma is? The layman name is LUNG CANCER, which is caused by Asbestos, otherwise known as Asbestos Lung Cancer.

Former Sailors - Marines who served aboard ships in the 1940's - 1950's - 1960's and early 1970's were exposed to **Asbestos**.

This means all 70,000 to 80,000 sailors and Marines who served aboard the U.S.S. Coral Sea were exposed to **Asbestos**, in their working spaces, living quarters or any compartment aboard the ship. Also to flight personnel who were on deck when incoming aircraft came aboard, their brakes being applied etc. Let's face it! All of us assigned to Naval Ships were subject to **Asbestos**.

Every one of us should have a chest X-RAY frontal and side views, and then the X-RAY must be read by a "B" reader. This procedure should be done every four to five years, after first X-RAY is taken and read.

Shipmates this is for your information only. Your Secretary Herman W. Doernbach has gotten me involved in this program. I must say that I have gone through this entire **Asbestos Lung Cancer** program and I was given a clean bill of health. Now I must get another X-RAY by August next year which would place me into the fifth year.

#### MEMORIAL TO U.S.S. CORAL SEA

For the past two and a half years we have been pursuing the idea of having a monument put in place at NOB Norfolk, VA. The Navy appeared to be dragging it's feet and that we were going now here in a hurry. We persevered, however, and now, at last, we can see the sun rising above the horizon.

We have been in recent contact with the Public Works Department at NOB, and at last we are feeling confident that such a memorial will come to be in the near future. The site is at Vista point, on the base, in the proximity of the memorial to the U.S.S. Iowa. From the report of our shipmates who have toured the area, they considered the site

The monument approximately five feet wide and about 4 foot tall, would be placed on site with an etching of the ship and the dates of her commissioning and retirement. The monument in dark gray is a handsome piece and well worth

of our ship's remembrance for all ages to see.

At the reunion banquet it was announced that an initial donation towards the funding of this memorial was made by Admiral Glindeman in the amount of \$100.00 This donation was prompted by the dissertation at the business meeting and with the agreement from our shipmates, that the U.S.S. Coral Sea should be remembered as a part of Naval history.

The entire ship's company present endorsed the idea and now we ask that each of us, younger or older members of the USS Coral Sea Association, make a donation, in whatever amount you can afford, to make certain that our ship

holds it's rightful place in Naval History in Norfolk, where she was born.

#### WORLD WAR II MEMORIAL

At the reunion in Williamsburg, the USS Coral Sea (CVA-43) Association voted to donate \$2,500 to the National World War II Memorial Campaign. Ground was broken for this long-needed tribute to WWII veterans on Nov. 11 Veterans Day....Individual members of the association who have not made a personal donation to this \$100 million project or who would like to do more can now add their bucks to a fund which will be credited to our association. Individual checks for any amount can be made payable to the World War Memorial Fund and sent to: World War II Memorial Fund, American Battle Monuments Commission, P.O. Box 98147, Washington, D.C. 20090-8147. To gain credit for our association write on the notation line of your check: "Mail code VG0QZ." That code ensures that your donation will be added to the \$2,500 already sent. (That code again is Victor-George-number 0-Queen-Zulu.)

President Clinton signed Public Law 103-32 in 1993 to officially start the project, although the effort to build a memorial began in the 1980's. Former Senator and WWII veteran Bob Dole chairs the campaign committee and Tom Hanks, who starred in the film "Saving Private Ryan," does celebrity spots on TV and in the print media to promote it.

More than \$90 million has been raised to date, most of that coming from individuals, business and industry, veteran's organizations, and others. The VFW, for example, has set a goal of \$7.5 million. Each state had been asked to

More than \$90 million has been raised to date, most of that coming from individuals, business and industry, veteran's organizations, and others. The VFW, for example, has set a goal of \$7.5 million. Each state had been asked to donate one dollar for every resident who served in the war. As of this fall, 45 states had made those contributions. Of the five who hadn't, legislation to do so has been introduced in Delaware and is expected to be introduced in Alaska, Hawaii, Nevada and New Mexico. If you live in one of those five states, you might want to prod your legislators to make sure your state is represented.

The memorial will be built on the Mall in the open area between the Lincoln Memorial and the Washington Monument. It will contain a great deal of landscaping, a pool and a waterfall. The ceremonial entrance off Washington's 17th Street will be framed by two massive flagpoles. There will be a series of 24 bronze relief panels depicting the war years at home and abroad. There will also be a visitor's plaza with arches, bronze columns, granite pillars and a freedom Wall to commemorate the more than 400,000 Americans who died in the war......For more information on this project, contact Association member Bill Williams, 100 Fairway Drive, Camp Hill, PA 17011 or by e-mail at wgmjwllm@epix.net

## USS CORAL SEA CVA-43 ASSOCIATION SCHOLARSHIP PROGRAM

#### **OUTLINE:**

The USS Coral Sea CVA-43 Association, hereinafter referred to as the Association, will award The Annual USS Coral Sea Remembrance Scholarship of \$2,000 (or an amount to be determined each year by the Association's Scholarship Committee) to the winner of an Association-sponsored essay contest.

#### **ELIGIBILITY:**

Applicants must meet all eligibility requirements. They must be either a son, daughter, grandchild, greatgrand-child, step-child or step-grandchild of an Association member in good standing on the date the scholarship is awarded or of a deceased member in good standing at the time of death. They must be a high school senior with a B or 3.0 grade point average. They must submit the official entry form accompanied by an essay of between 800 and 1,000 words on one of the following topics: "How to Improve the Homogeneity of American Society" "What it means to Me To Be an American Citizen" or "Why We Need To Keep Our Armed Forces Strong." They must agree to use the scholarship for their personal education at an accredited two-year or four-year United States college, university or post-secondary technical-vocational school.

#### **HOW TO APPLY:**

Applicants must obtain an official entry form from their relative who is a member in good standing of the Association (or from the committee chairman in situations where the member has died,) complete that form and submit it to the address listed no later than April 15. The form must be accompanied by the essay as described above under "Eligibility," by two letters of recommendation and by a high school transcript. Entries will be judged by the Association Scholarship Committee. A winner will be selected no later than June 10 and notified in writing within five days by the chairman of the Committee. (The winning essay will be published in the Fall edition of the Association newsletter.)

#### **DETAILS OF ENTRY:**

An original entry form must be filled out completely. The information requested must be typed or legibly printed. Only one entry is allowed each year from any applicant. A winning applicant may apply in subsequent years but will be considered only if there are no applications from other applicants. The essay must be the original work of the applicant. It must be typed double-spaced on one side of a sheet (s) of paper. All reference sources for the essay must be listed and footnoted. Two dated and signed letters of recommendation must be submitted from a clergy person, teacher, employer or community leader who has had a professional or working relationship with the applicant; relatives of the applicant cannot submit such a letter. An official high school transcript showing all marking periods to date of the applicant's senior year and grade point average for those periods must also be submitted. The entry form, letters of recommendation and transcript must contain the applicant's full name. However, neither the applicant's name nor address may appear on the essay; instead, the only identification on each page of the essay will be the applicant's Social Security number in the upper right hand corner. A check for the scholarship will be mailed by the Association to the college, university or school designated by the winning applicant. All material - entry form, letters of recommendation, transcript and essay - must be mailed in one envelope to the chairman of the Association Scholarship Committee no later than April 15.

#### **CRITERIA OF JUDGING:**

Essays will be judged and a winner selected by a three-person committee elected by the Association membership. A fourth person - the committee chairman - will be appointed by the Association president. (Relatives of committee members are not eligible to enter the competition.) The chairman will be the only committee member who will know the identity of the essay writers and therefore will not have a vote on selection of the winner. Terms for the initial Scholarship Committee will be: one for one year; one for two years; one for three years. At each subsequent annual meeting of the membership one person will be elected to the committee for a three-year term to replace the retiring member. The chairman will send copies of all essays (identified only by Social Security numbers) to each of the three committee members but will not divulge the names, addresses or Association relationships. In addition, the chairman will send to the three committee members copies of all other material required of applicants, namely, the letters of recommendation, the high school transcript and page two of the official entry form, making sure that the applicant's name does not appear. In case of a tie vote, the applicant with the highest grade point average foe the entire senior year will be judged the winner. Essays will be judged on the originality of thought, adherence to topic, completeness, quality of writing, spelling and punctuation. All material submitted to the Association scholarship program becomes the property of the Association and cannot be returned to the applicant.

Jim Williamson asked me to forward this letter I got from the daughter of Ensign O'toole who was killed landing on the Coral Sea in 1954. I was a member of his squadron, The Red Rippers. He thought printing the letter might shake up a few more memories from some of the guys who may have known him, and maybe she can get some more information.

Hi, I'm Kathleen O'Toole, Ensign Austin E. O'Tooles daughter. (one of 4 girls....one boy) I want to thank you for the wonderful article I read about my Dad in the Coral Sea mishap web site.....Med cruise 1954

I was 6 years old when my Dad died on the Coral Sea. Many people think my brother and sisters and I could not possibly remember our Dad....but I do. I remember him holding me on his shoulders at a parade so I could see. I remember we were all RED RIPPERS, and we called ourselves that. We had red pajamas, and would take baths and get all cleaned up, one time going to see Peter Pan at the local Drive In, and Daddy ran over a bike left in the drive way. He marched us all into the house and to bed we went. No movie, that night.

I remember him playing April Fools jokes with us....

saying prayers before bed at night, and I remember his reading aloud to us. He cut our bangs, and when I washed my hair, he rubbed it towel dry very very hard. He was a big lovable man, and I've missed him my whole life. At 6 I did not really understand "death" I thought maybe he was on a cruise and we wouldn't see him for awhile. The day I understood death, was when I was playing with some neighbor children, and the carpool of Daddies pulled into the drive way.....The uniformed men all got out, and all the children ran and hugged and got swung around by their Daddies. That's when I realize I would never see my Daddy again.

I cried hard for the first 10 years, 3 or 5 times a year. I remember being 17 years old...and climbing in my mom's lap, and bawling like a baby, because I missed him so much. As I got older I noticed I only was sad two or three times, always on the anniversary of his death, and a few other times. I'm now 52 years old. 21 years older than my father when he died. Only until just recently can I think of him without crying. We Irish are an emotional bunch. I really want to thank you for s haring your memories, of the day my Dad crashed his Banshee. My mom was at the funeral of the skipper of the squadron, when they came to tell her. I've sought out Navy men my whole life, and anyone close to my Dad's age, I quizzed them about life, then. I've learned that sometimes half the squadron perished in accidents, and many many men gave their lives for their country. I know, (from my mom) that my dad loved flying....and wanted to be buried at sea....

He would fly over our house in Texas and tip his wings to her, if she was in the garden. Some of his buddies have stayed in touch, and have s hared some of their stories. All this helps. If there is anything else you could tell me about my Dad, I would appreciate any little thing you could remember.

I remember his brother coming to visit me in Park City, UT, and he asked why did you move here? Coronado, CA is a wonderful place to grow up, why leave? My answer was "open space" I need to not be so visually stimulated. That reminded him of a story I had never heard, about my uncle visiting us in Jacksonville, and made a comment...."Austin, (looking at his big back yard) You'll have to build a fence to keep your children in. He said "I'm not fencing my kids in, hell if someone wants to fence them out they can do it! Won't fence any kid of mine in!....So, I think I'm like my dad.....I love open space. I don't think I would like to be a pilot .... but I do understand..... Thanks for listening.






