



This fund is to be funded by a \$10,000 starter contribution from the Association, in addition to contributions from the membership. In addition, the Association will hold 50-50 raffles on Friday and Saturday evenings, at the reunion. 50% of the donations will go to the scholarship fund and 50% will go to the winner of the raffles. Hopefully, the fund will be self sustaining within a seven year period, at which time we could start a second scholarship, if desired by the membership.

The committee that oversaw this project has done an outstanding job and deserves a standing ovation for a job well done. We have a scholarship program that we can be proud of, and one that can grow as the Association grows.

There were several proposed changes to the By-Laws. These all failed to carry a majority vote at the general meeting.

The Holiday Inn at Portsmouth, Virginia was selected as the site for the reunion in 2003, This event will be sponsored by the Board of Directors and will be chaired by **John Plude**. Owing to the large number of members in the greater Norfolk area, this should be well-attended.


President



Laughlin, NV-10/13/01

The USS Coral Sea CVA-43 Association's 23rd Annual Reunion was held at Don Laughlin's Riverside Hotel, Laughlin, Nevada, October 11-14, 2001.

The Executive Board met Thursday evening and discussed several items which were later brought to the floor during the general business session the next day. Among the items discussed and voted were the proposed changes to the By-Laws and the **Coral Sea Scholarship Program.** Election was held for a new Secretary and one 3-year Board of Directors.

At the general business meeting of the USS Coral Sea CVA-43 Association, retired Rear Admiral Henry P. Glindeman gave a presentation and talked to the members asking for help to save the *USS Ranger CV-61* from being sold for scrap.

RADM Glindeman once served aboard the USS Coral Sea CVA-43 as Executive Officer and Commanding Officer of VF-154, and as Commander Air Group 15 from 1962 to 1965. Later in his career he became the Commanding Officer of the USS Ranger CV-61 from September 1971 to May 1973.

The USS Ranger was decommissioned in 1993 and is presently berthed in Bremerton, Washington Naval Shipyard as part of the mothball fleet

Glindeman said, "Under current planning when the USS Constellation CV-64 is decommissioned in 2003, the Ranger will be transferred to the disposal list. At that time she will be eligible to be donated as a museum/educational facility, or sold to the highest bidder.

There is an organization that has been working hard for more than two years to be in a position to have a plan and funding in place to be awarded to the *Ranger* as a museum/educational facility by the Navy Department. This organization is **Seaport Northwest Inc.** in Everett, Washington, just north of Seattle on Puget Sound. I have

made a commitment to save the *Ranger*. I have accepted a seat on the Board of Directors of Seaport Northwest. Also, I am involved with the USS Ranger Reunion Association. I served on the Board of Directors until term limits prevented my continuation there. I was appointed Special Advisor to the president and point of contact between the Association and Seaport Northwest.

Here is my request to you. I am asking for dollar donations to save Ranger from the scrap heap. This project will take millions of dollars but we need your donation as seed money for printing, and mailing cost.

I have always supported you, the Coral Sea association. I always felt as part of this organization. I have helped you before, now I am asking you to help me."

The luau was held in the *Starview Room* of Don Laughlin's Riverside Hotel on Friday evening, October 12. Whole roasted pigs were served with lots of fruits and vegetables.



From a speech made by Capt. John S. McCain, (USN-Ret) who represents Arizona in the U.S. Senate:

As you may know, I spent five and one half years as a prisoner of war during the Vietnam War. In the early years of our imprisonment, the NVA kept us in solitary confinement or two or three to a cell. In 1971 the NVA moved us from these conditions of isolation into large rooms with as many as 30 to 40 men to a room. This was, as you can imagine, a wonderful change and was a direct result of the efforts of millions of Americans on behalf of a few hundred POWs 10,000 miles from home.

One of the men who moved into my room was a young man named Mike Christian. Mike came from a small town near Selma, Alabama. He didn't wear a pair of shoes until he was 13 years old. At 17, he enlisted in the US Navy. He later earned a commission by going to Officer Training School. Then he became a Naval Flight Officer and was shot down and captured in 1967. Mike had a keen and deep appreciation of the opportunities this country-and our military-provide for people who want to work and want to succeed.

As part of the change in treatment, the Vietnamese allowed some prisoners to receive packages from home. In some of these packages were handkerchiefs, scarves and other items of clothing. Mike got himself a bamboo needle. Over a period of a couple of months, he created an American flag and sewed on the inside of his shirt. Every afternoon, before we had a bowl of soup, we would hang Mike's shirt on the wall of the cell and say the *Pledge of Allegiance*. I know the Pledge of Allegiance may not seem the most important part of our day now, but I can assure you that in that stark cell it was indeed the most important and meaningful event.

One day the Vietnamese searched our cell, as they did periodically, and discovered Mike's shirt with the flag sewn inside, and removed it. That evening they returned, opened the door of the cell, and for the benefit of all us, beat Mike Christian severely for the next couple ofhours. Then, they opened the door of the cell and threw him in. We cleaned him up as well as we could. The cell in which we lived had a concrete slab in the middle on which we slept. Four naked light bulbs hung in each corner of the room. As I said, we tried to clean up Mike as well as we could. After the excitement died down, I looked in the corner of the room, and sitting there beneath that dim light bulb with a piece of red cloth, another shirt and his bamboo needle, was my friend, Mike Christian. He was sitting there with his eyes almost shut from the beating he had received, making another American flag.

He was not making the flag because it made Mike Christian feel better. He was making that flag because he knew how important it was to us to be able to Pledge our allegiance to our flag and country.

So the next time you say the Pledge of Allegiance, you must never forget the sacrifice and courage that thousands of Americans have made to build our nation and promote freedom around the world. You must remember our **duty**, our **honor**, and our **country**.

"I pledge allegiance to the flag of the United States of America and to the republic for which it stands, one nation under God, indivisible, with liberty and justice for all."





### SCHOLARSHIP PROGRAM OPENS

The Association has launched *The Annual USS Coral Sea Remembrance Scholarship* with the first recipient of \$2,000 to be chosen next spring.

President Charles Whitcomb has named Bill Williams as chairman of the Scholarship Committee for one year. Members of the committee will be named later. Williams also served as chairman of the Scholarship Formulation Committee, which developed the program over the past two years. Members of that committee were Guy Dunbar, Bill Eannetta, Henry Kleeman, Bill Wilson and David Yokley.

The scholarship is designed to help relatives of former Coral Sea crewmen with college expenses. Rules of eligibility and instructions on applying for the scholarship are published in this edition of *The Breeze*, along with an official entry form.

The entry period for the year 2002 award opens January 1 and closes April 15. Former crewmen or parents/guardians who sponsor an entrant and the entrants themselves are asked to carefully read all of the rules and the entry form before submitting an entry. All material required under the rules must be submitted to the committee chairman in one package.

The chairman's address is listed at the end of the entry form.

### USS CORALSEA CVA-43 ASSOCIATION SCHOLARSHIP PROGRAM

### **OUTLINE**:

The USS Coral Sea CVA-43 Association, hereinafter referred to as the **Association**, will award The Annual USS Coral Sea Remembrance Scholarship of \$2,000 (or an amount to be determined each year by the Association's Scholarship Committee) to the winner of an Association-sponsored essay contest.

### **ELIGIBILITY**:

Applicants must meet all eligibility requirements. They must be either a son, daughter, grandchild, great-grandchild, step-child or step-grandchild of (1) an Association member in good standing on the date the scholarship is awarded, (2) or of a deceased member in good standing at the time of death, (3) or of a non-member who was killed in the line of duty while serving aboard the USS Coral Sea in ship's company or air group, or was captured as a prisoner of war, or was injured in the line of duty to the extent that separation from the U.S. Navy was required. They must be a high school senior with at least a B or 3.0 grade point average. They must submit the official entry form accompanied by an essay of between 800 and 1,000 words on one of the following topics:

"How To Improve the Homogeneity of American Society," or

"What It Means to Me To Be an American Citizen," or

"Why We Need To Keep Our Armed Forces Strong"

They must agree to use the scholarship for their personal education at an accredited two-year or four-year United States college, university or post-secondary technical-vocational school.

### **HOW TO APPLY:**

Applicants must obtain an official entry form from their relative who is a member in good standing of the Association (or from the committee chairman in situations where the member has died), complete that form and submit it to the address listed no later than <u>April 15</u>. The form must be acc-

ompanied by the essay as described above under "Eligibility," by two letters of recommendation and by a high school transcript. Entries will be judged by the Association Scholarship Committee. A winner will be selected no later than June 10 and notified in writing within five days by the chairman of the Committee. (The winning essay will be published in the Fall edition of the Association newsletter.)

### **DETAILS OF ENTRY:**

An original entry form must be filled out completely. The information requested must be typed or legibly printed. Only one entry is allowed each year from any applicant. A winning applicant may apply in subsequent years but will be considered only if there are no applications from other applicants. The essay must be the original work of the applicant. It must be typed doublespaced on one side of a sheet(s) of paper. All reference sources for the essay must be listed and footnoted. Two dated and signed letters of recommendation must be submitted from a clergy person, teacher, employer or community leader who has had a professional or working relationship with the applicant; relatives of the applicant cannot submit such a letter. An official high school transcript showing all marking periods to date of the applicant's senior year and grade point average for those periods must also be submitted. The entry form, letters of recommendation and transcript must contain the applicant's full name. However, neither the applicant's name nor address may appear on the essay; instead, the only identification on each page of the essay will be the applicant's Social Security number in the upper right-hand corner. A check for the scholarship will be mailed by the Association to the college, university or school designated by the winning applicant. All material entry form, letters of recommendation, transcript and essay must be mailed in one envelope to the chairman of the Association Scholarship Committee no later than April 15

### **CRITERIA OF JUDGING:**

Essays will be judged and a winner selected by a three-person committee elected by the Association membership. A fourth person -- the committee chairman -- will be appointed by the Association president. (Relatives of committee members are not eligible to enter the competition.) The chairman will be the only committee member who will know the identity of the essay writers and therefore will not have a vote on selection of the winner. Terms for the initial Scholarship Committee will be: one for one year; one for two years; one for three years. At each subsequent annual meeting of the membership one person will be elected to the committee for a three-year term to replace the retiring member. The chairman will send copies of all essays (identified only by Social Security numbers) to each of the three committee members but will not divulge the names, addresses or Association relationships. In addition, the chairman will send to the three committee members copies of all other material required of applicants, namely, the letters of recommendation, the high school transcript and page two of the official entry form, making sure that the applicant's name does not appear. In case of a tie vote, the applicant with the highest grade point average for the entire senior year will be judged the winner. Essays will be judged on the originality of thought, adherence to topic, completeness, quality of writing, spelling and punctuation. All material submitted to the Association scholarship program becomes the property of the Association and cannot be returned to the applicant.

### **IMPORTANT NOTES:**

To use the Scholarship Program entry form found in this edition, please xerox copy pages 9 and 10 separately on <u>ONESIDE</u> only. Pages 9 and 10 must be submitted on one side only together with other requested material. To obtain entry form, please contact the Scholarship Program Chairman.



### MINUTES OF THE MEETING ON 13 October 2001

Date this record was transcribed: 7 Nov 2001

(Due to the absence of a Secretary during the meeting, information contain in this minutes were extracted from an audio recording taken during the session. Some information were notes from observations taken by the editor outside of the audio recording.

Note 1: The meeting was scheduled for 0930 but was delayed due to technical difficulties encountered by the hotel manangement in setting up the PA system.)

1. The meeting was opened by President Charles Whitcomb with the Pledge of Allegiance.

Roll call of the Officers followed. Officers present:

- 2. In the absence of a secretary, President Whitcomb read the minutes from the last meeting. Motion was made to accept the minutes as read. Motion seconded -- minutes was accepted as read.
- 3. President Whitcomb called for the Financial Report from the Treasurer.
- 4. Treasurer John Weber pointed out to the copies of the written financial report that were distributed earlier to the general membership. Treasurer Weber explained that this report was written at the end of June (end of Association's fiscal year), and that it has been updated since then. Treasurer Weber read the updates. Treasurer Weber further explained the proper procedure when sending money to pay for dues, raffles and other donations. For dues, send money to the Secretary for record update and processing; for raffles and other donation, send money to the committee chairman handling the project. Motion was made to accept the Financial Report -- motion was seconded and accepted.
- 5. President Whitcomb called for the report of the sub-audit committee. Sub-audit committee reported no discrepancy on the figures from the audit.
- 6. President Whitcomb called the members from each table to introduce themselves. Each member stood up one at a time and introduced himself.
- 7. President Whitcomb called for unfinished business.
- 8. Bill Williams made a report on the Scholarship Program. Made mention of the proposal which was included in the final draft of the program. Made mention of the sale of his book, "Heroes Among Us" and emphasized that part of the profit will go to the Scholarship Fund. Motion was made to accept the proposal and the report on the Scholarship Program. Motion was seconded and accepted.

(A question was raised by a member from the floor as to how the program is going to be financed. The President explained what was decided at the Thursday night Board meeting that \$10,000 will be deposited into the fund as "seed" money for the opening of the program for the first year (which will come out next year - 2002). The President mentioned that a gentleman has already donated \$1,000 into the fund. Donation by the members earmarked to the Association will go into the Scholarship Fund, half of the proceeds from 50/50 drawings will go to the Scholarship Fund. The seed money will be drawing interest possibly to fund a second scholarship sometimes in the future. Bob Mackey made a motion to acept the report of the Executive Board for funding the Scholarship Fund. Motion was seconded and accepted.

Bob Mackey asked the question: "Is the Scholarship Fund criteria be entered into the constitution By-Laws, or is it a policy situation?" President Whitcomb replied: "Policy situation."

Bob Mackey: "Then it has to be entered into the policy book written by the Secretary of the Association."

10.ELECTION.

(Election for a new Secretary and one Board of Directors for a 3-year term).

President called for any nomination to the office of the Secretary. Bill Williams made the nomination of MG Cordero for Secretary. MG Cordero accepted the nomination. Another member submitted a nomination of Herman Doernbach for Secretary. Herman Doernbach declined the nomination. Motion was made to close the nomination for Secretary. Motion was seconded -- nomination was closed. President Whitcomb called for nomination for a 3-year Board member. Nomination was made for Jon E. Lickey. (Jon Lickey was absent. Jon Lickey is the outgoing Board member, but has previously adviced the President that if nominated for re-election, he will accept.). Nomination was submitted from the floor for Bob Miller for the 3-year Board member. Bob Miller declined the nomination. Motion to close the nomination for 3-year Board member -- seconded -- nomination for 3-year Board member was closed. Motion was made to accept the nominated officers. Motion was seconded. A member from the floor pointed out that since the nominated officers were voted or accepted by acclaimation, then there was no need to mark the written ballot.

### 11. 2003 REUNION PROPOSAL.

The reunion chairman made the following report:

- (a) Proposed reunion site for 2003 is at the Holiday Inn, Portsmouth, VA
- (b) When: 1st weekend of October 3-4-5
- (c) Rates: \$75 plux tax = \$83.75 per person.
- (d) Package rate (2 nights and 4 meals):
  - -- \$268.34 for one person
  - -- \$370.18 for two
  - -- \$472.00 for three

(Note: This package rate may not be true in 2003).

Motion was made to close the discussion on proposed site -- seconded -- closed.

- 12. Discussion on the proposed changes in the By-Laws. After lenghty discussion on the proposed changes, President Whitcomb called for a written vote on the proposed amendments. Ballots were collected to be counted.
- 13. Retired RADM Henry P. Glindeman made an appeal presentation to support the project to save the USS Ranger (now decommissioned), from being scrapped. RADM Glindeman is the Chairman of the Board of the Ranger Museum Foundation. After the Admiral's presentation, a motion was made that the Association donate \$5,000 to the Ranger Museum Foundation fund. Motion was seconded and accepted.
- 14. President Whitcomb brought up the subject about a suggestion that was made that the ship's slogan "Ageless Warrior -Older and Bolder" should be changed. Short discussion followed and a motion was made to leave the slogan as is. Motion was seconded and noted.
- 15. Chaplain Linzey said a few words on the subject of getting the information thru the channel when a member passes away.
- 16. RADM Glindeman made an announcement about the Donor Award program for the USS Ranger Museum Foundation. For donors who donate the following amount will receive the following:

\$100 - certificate and ID card when the ship opens up with a free pass for one year.

\$500 - lifetime pass to visit the Ranger Museum along with the family.

\$1000 - will have his name listed on the Ranger door or the Educational facility.

17. President Whitcomb introduced and read a resolution that the Association support the decision of the Commander-in-Chief regarding the battle on terrorism. The resolution reads:

"We, the 1400 members of the USS Coral Sea (CVA-43) Association, do hereby resolve to support and defend by all possible means the decisions of our Commander-in-Chief, the Congress and the Joint Chiefs of Staff in the lengthy and necessary process of eliminating terrorists and terrorist organizations from the face of the Earth.

Sign this 13th day of October 2001 in a voting session at Laughlin, Nevada."

Motion was made to accept the resolution -- seconded -- motion accepted.

18. President Whitcomb announced the result of the ballot cast on the proposed changes of the By-Laws.. The vote on each of the proposed change reads as follows:

Proposal #1 = 46 Yes Proposal #2 = 41 Yes Proposal #3 = 17 Yes Proposal #4 = 36 Yes Proposal #5 = 36 Yes Proposal #6 = 34 Yes

(All proposals were defeated and so recorded)

19. Motion was made to adjourn -- seconded. Meeting was adjourned at 12:18 PM





"I, Greg Raelson, do solemnly swear to support and defend the Constitution of the United States against all enemies, foreign and domestic. I will bare true faith and allegiance to the same. I will obey the orders of the President of the United States and the officers appointed over me, according to regulation of the uniform code of military justice. So help me God."

Also, any person who was assigned to the Commissioning crew (plank owners), even if they spent less than 90 days aboard shall be eligible for membership.

### DUES

Association membership dues is \$10 per year. Dues for membership is not limited to one year when submitted for renewal or first-time application. Any amount submitted over the annual dues, will be automatically earmarked to the Association's Scholarship Fund program.


