Number 24 in a Series by Rom Braun FT2 (1953 - 1956)

The FT "A" School in Bainbridge got off to a good start. To teach us FTs electronics, the class room lectures were reinforced by the lab assignments. The lab exercises (the first twelve weeks of class) were built around a radio receiver. We learned how to solder, make good connections to tube sockets (hey electronics in those days were vacuum tubes!) and make clean and neat wiring runs.

The first section of the radio was the power supply. In those days you had the filament supply (6.3 vac) which heated the vacuum tube's filament which in turn heated the vacuum tube's cathode, while the other part of the power supply provided the high voltage (250 vdc) for the vacuum tubes' plate supply. WOW! - really different compared to voltages in today's power supplies!

Other sections of the radio consisted of the audio amplifier, IF amplifier, the RF amplifier, the variable frequency oscillator, the tuner, and of course the speaker. Various pieces of test equipment were used to check out the sections as they were completed. As a result all the radios worked when completed.

Those lab exercises were a good choice in those days as everything at that time was analog as compared to today's digital world.

Every Friday morning we were tested and every Friday afternoon we had a Field Day exercise! The Field Day exercises were quite simple - sweep and mop the wooden decks, polish the brass work - remember the brass on the fire fighting equipment.



Then the weekend started and off to one of the great cities like Baltimore, New York City, or Washington DC. Oh yes, one liberty section had to stay behind with the weekend duty.

After the first twelve weeks, we began the detailed study of the various firecontrol systems. But that is another short story!

#### **VETERANS: VA OFFERS MEDICAL BENEFITS**

If you are a military veteran, you're probably entitled to prescription drugs through the Veterans Administration (VA) for no more than \$7 for a 30 day supply. In some cases, they are free.

Unfortunately, this benefit has not been widely publicized, and many veterans are missing out.

"Our veterans earned VA health care' and we should make sure they get it," said UAW Vice President Cal Rapson, who directs the union's Veterans Affairs Department.

Rep. Ronnie Shows, D-Miss., recently revealed a memo from the department of Veterans Affairs to the VA urging it not to advertise its services in order to keep its cost down.

The memo cites "a growing crisis related to the continued demand for health care services that exceeds our resources," noting a 13.5 percent annual increase in users of VA health care services.

"I am shocked that high VA Officials are ordering VA health care providers to keep VA health care a secret," said Shows, a member of the House Veterans Affairs Committee. "Veterans put their lives on the line for our country. They didn't ask for anything in return except for the government to keep the promises that were made to them."

Veterans' spouses, children and dependent parents may also be eligible.

VA health care enrollment more than doubled, from 2.9 million people in 1995 to 6.2 million in 2001. The solution, according to the memo, is to stop telling veterans about the health care services they have earned and to which they are entitled.





The memo orders a halt to any VA communication with veterans or the general public that would encourage qualified veterans to take advantage of the VA health care system.

Despite the Bush administration's rebuff, qualified veterans are entitled to aid.

Here are the requirements:

- \* You must have served full time in the military as a member of the Army, Navy, Air Force, Marines or Coast Guard, or as a commissioned officer of the Public Health Service, the Environmental Services Administration, or the National Oceanic and Atmosphere.
  - \* You must have been discharged under than dishonorable conditions.
- \* You must get your medications from a VA facility. More than 1,000 VA health facilities are available.

## MIDWAY MUSEUM PROGRESS REPORT Achievements to date October 23, 2002

In our nearly ten-year effort to bring ex-USS MIDWAY to San Diego to serve as a world-class naval aviation museum dedicated to entertainment, education, and honoring American naval and marine personnel, we supporters have accomplished the following:

- 1. Developed an opening-day museum design with a budget of \$3.5 Million, based on existing successful carrier museums.
- 2. Arranged for bank loans totaling \$5.75 Million, available after donation of MIDWAY.
- 3. Raised and spent \$2 Million, obtained almost entirely from private donations and loans.
- 4. Created a Directors' Reserve Loan of \$1.1 Million, to be drawn, if needed, after the bank loans.
- 5. Secured a total of \$400,000 in vendor commitments and donor pledges to be paid after the donation of MIDWAY, raising to total project funding to be \$9.25 Million.
- 6. Won the approval and support of 86% of San Diego citizens, as measured by two professional polls.
- 7. Provided nearly 200 presentations on MIDWAY before civic groups, such as Rotary, Kiwanis, Lions, Optimists, veterans, reunions, and business, church and alumni groups, etc.
- 8. Appeared before countless meetings of the North Embarcadero Alliance, the Port Commission, the Port Staff, the California Coastal Commission (where we earned a unanimous approval vote), the State Lands Commission Staff, and a myriad governmental agencies.
- 9. Won an \$8 million State grant for the repair of Navy Pier, MIDWAY's future home.
- 10. Responded positively to Navy application questions through nine editions comprising 153 questions and involving 1,773 pages of documents, charts, and exhibits, plus answering 56 questions from the Port and the State Lands Commission with 346 more pages of documentation.
- 11. Established a full-scale aircraft restoration facility, manned by several dozen volunteer expert artisans who have already beautifully restored several carrier-based naval aircraft.



## Plank Owners

A "plank owner" is an individual who was a member of the crew of a ship when that ship was placed in commission. In earlier years, this applied to a first commissioning; since then, it has often been applied to one who was part of a recommissioning crew as well. "Plank owner" is not an official Navy term, and has consequently been variously defined by different Navy units.

Plank-owner certificates are procured by and issued to crew members of the ship being commissioned; they are not officially issued by the Navy. Some ships' crews design their own, while others purchase them from commercial sources. Perhaps the best-known of these are the ones sold by the United States Naval Institute. These color certificates can be obtained as blanks; if the purchaser wishes to provide the necessary information, they can be filled in for an additional charge.

Illustrations and prices of these certificates can be obtained from the Naval Institute Press, Annapolis, MD 21402.

In the case of ships with wooden decks, if the veteran has a plank owner certificate or statement of service showing that he was on the ship when it was commissioned, the veteran can write to the Naval Historical Center's Curator Branch, and request a piece of deck planking. If the veteran meets the above criteria and the Curator Branch has possession of deck planking, the plank owner or his widow can receive a small section of the deck. For more recent ships with metallic decks, the Navy is regretfully unable to issue deck sections.

#### MUSINGS OF AN EX-SAILOR

Coming out of Bainbridge, MD boot camp (4/52), I was asked what ship I'd like, if possible. I said the biggest on the East Coast. I figured it would be a long swim home if it went down, but that I'd get three squared a day and a clean bunk. The USS CORAL SEA CVB 43 was my assignment - but she was out in the Mediterranean. So they sent me to TAD Norfolk to mess cook until I could be sent to her.

Meanwhile, not being familiar with carriers, I strolled down to Pier 7 and visited the USS SIBONEY. Little did I know this wasn't a big carrier. A few months later I was put aboard a troop transport in Staten Island, NY. There were 200 soldiers going to Austria and 200 sailors going to ships in the Med.

First eight days I was sick as a dog (mal de mer). On the ninth day a soldier "saved" my life - he taught me how to play chess. Mind over matter. On the eleventh day we arrived in Naples, Italy. Herded to a plane for Nice, France. But, before taking off, one of the engines burst into flames! My first air flight and now this! Fortunately, it was resolved. Next adventure was a hectic bus ride from the airport in Nice to Golfe Juan, France (winding, close mountain cliffs).


Finally a long boat ride out tot where the CORAL SEA was anchored. My God! The SIBONEY could have fit on the flight deck. It was three football fields long and a veritable fortress. Fourteen 5" 54s and I think almost twenty 3" 50 Cal.

It was LOVE at first sight. I spent two happy though hectic years (many plane accidents - I wasn't involved) until I left the ship when she came to NY (6/54) to go to FTA school in Washington, DC.


